The number of Lifeguards is determined according to AFI 34-110. These numbers will be strictly adhered to as stated above.

For more than 150 participants, a waiver must be obtained from the 42nd FSS Commander. In the case of a large number of children, extra guards may be required at an additional fee.

Listed below are the terms of agreement for pool party reservations.

____ 1. It is the responsibility of the requestor to ensure that the participants at the pool follow the rules and guidance given by the lifeguards and on this reservation form.

____ 2. If the number of individuals in the pool (in water) exceeds the lifeguard requirements, then the number of individuals over the limit must vacate the pool (water) until the correct number of lifeguards are present.

____ 3. The time of the pool party includes clean up time. The party must be terminated to allow time for clean up or an additional fee will be charged.

____ 4. Functions may be cancelled due to bad weather, pool malfunctions, or lack of lifeguards. The Pool Manager or the Lead Lifeguard reserve the right to cancel the function for any of these reasons and will give as much advance notice as possible.

____ 5. Groups and organizations may bring their own food and drinks. There is absolutely no smoking inside or directly outside the facility. Smoking must be done at least 50 feet from the facility. Alcoholic beverages may be served with written authorization from the 42nd FSS Commander. No food is allowed in the main pool area but drinks may be consumed at the tables and benches around the pool. Music levels must be kept to a level as to not disturb the housing areas near the pool.

____ 6. Participants attending private parties are subject to other rules which the guards may deem necessary for the safety and welfare of all. They are authorized to issue rules either verbally or in writing and enforce them.

____ 7. It is the responsibility of the requestor to ensure that the area is left neat and clean. This includes taking trash bags to areas instructed by the lifeguards. Trash receptacles and bags will be provided. If the facility is not cleaned or is not cleaned by the end of the scheduled pool party, a minimum additional fee of \$25 will be charged.

____ 8. These rules have been prepared in accordance with Air Force safety, sanitation, and alcohol control instructions. Non-compliance of these rules may cause the offender to be denied the use of the pools, and the incident will be reported to the offender's commander.

____ 9. Absolutely no money can be charged to the people coming to a private pool party.

A \$10 deposit is required to confirm your reservation. This amount will be deducted from the total cost of your party. However, this deposit is non-refundable unless the party is cancelled one week prior to the event.

The entire cost of the pool party must be paid no later than one week prior to the scheduled event to the Maxwell or Gunter Pool or the party will be cancelled.
